# REQUIREMENTS

Upon arrival, please visit the secretariat to settle the towing fees. You will also receive information about the designated trailer parking areas and the camping facilities.

The following documents are required (email copies sent in advance are highly appreciated):

### **Pilot**

- SPL Licence and LAPL/ICAO Class 2 medical certificate, valid at least until July 6<sup>th</sup>
- FAI license valid for the current year

## **Sailplane**

- ARC/PTF, valid at least until July 6th
- Third-party insurance, ICAO compliant, with a minimum coverage of € 1.500.000,00
- Radio station licence (aircraft)
- Flarm or any Flarm-compatible traffic awareness device (mandatory)
- ELT, PLB, Spot or other personal or aircraft tracking device (highly recommended)

We kindly ask all pilots to be capable of moving their gliders independently to the parking area after landing. Additionally, pilots must have a crew available for retrieves from outlandings. Registration and competition markings must be displayed on the fin, wing dollies, tow bars and

Two compact off-road vehicles are available for quick relocation of sailplanes immediately after landing. However, please be prepared for potential waiting times if there is a high demand for this service.







### **RACE AREA and AIRSPACE**

The competition area spans from East to West along the Alpine arc and the foothill region.

Turn-point and airspace files, along with all relevant sporting and local rules, will be made available on the competition website as soon as possible. Notifications will be sent to all registered participants in due course.

### **INFRASTRUCTURE**

Throughout the competition, pilots will have access to the following services:
